- 5. Sealed Bids must be submitted to the office of **Sandhikharka Municipality** *Arghakhanchi* on or before 12:00 hours (noon) with in 31th day of notice publication.
- 6. Bids shall be opened physically in the presence of Bidders' representatives who choose to attendat 13:00 hours on 31th day of notice publication at the office of Sandhikharka Municipality Arghakhanchi.
- 7. Pre-Bid meeting shall be held at the office of Sandhikharka Municipality Arghakhanchi at 14:00 hours on 16th day of notice publication.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission..
