2. **Sandhikharka Municipality, Arghakhanchi** invites *sealed or electronic* bids from eligible bidders for the procurement of **Supply and Delivery of High Density Polyethylene Pipes under National competitive bidding procedures specified in Public Procurement Act and Regulations.**

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Sealed or electronic bids must be submitted to the office **Sandhikharka Municipality, Sandhikharka, Arghakhanchi** by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on **2075/10/25 (8th Feb, 2019)** . Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 pm on 2075/10/25 (8th Feb, 2019)** at the office of **Sandhikharka Municipality, Sandhikharka, Arghakhanchi**. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 2,40,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
