- 5. Sealed or electronic bids must be submitted to the office Sandhikharka Municipality, Sandhikharka, Arghakhanchi by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 Noon on 2075/11/10 (22nd Feb, 2019).Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 pm on 2075/11/10 (22nd Feb, 2019) at the office of Sandhikharka Municipality, Sandhikharka, Arghakhanchi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of *Rs.1,88,000.00*, which shall be valid for 30 days beyond the validity period of the bid.
