Sealed or electronic bids must be submitted to the office **Sandhikharka Municipality, Sandhikharka, Arghakhanchi** by hand/courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **10-03-2019 (2075-11-26) 12:00 hours**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend on **10-03-2019 (2075-11-26) 13:00 hours** at **Sandhikharka Municipality, Arghakhanchi**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Rs.1,30,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
