Invitation for Bids for the **SM/B/22/2076-077** Contract Identification No: **SM/B/22/2076-077**

1. The Government of Nepal **Sandhikharka Municipality** towards the cost of **Construction of Ward office Building (ward No.3,4,9&11)** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of Ward office Building (ward No.3,4,9&11) SM/B/22-2076-77**. Bidding is open to all eligible as per Section V of bidding document..
2. **Sandhikharka Municipality** invites electronic bids from eligible bidders for the construction of **Construction of Ward office Building (ward No.3,4,9&11)** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 (Ten) years: NRs. **6,00,00,000.00**
 - Minimum Work experience of similar size and nature at least one contract successfully completed within the last Ten years amount of **NRs, 63500000.00**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **2076/10/26 [9th Feb,2020] 12:00Hrs.** Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **2076/10/26 [9th Feb,2020] at 12:30 hrs** at the office of **Sandhikharka Municipality, Sandhikharka, Arghakhanchi.** Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of **NRs. 20,00,000.00 (Twenty Lakh only).** Which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
