2. Sandhikharka Municipality invites sealed bids from eligible bidders for the construction works for Office Building.
 3. Bidding documents may be purchased from the office of Sandhikharka Municipality on the submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table until the 3rd July, 2016 (19th Ashar, 2073 BS) within office hour, the bidder shall be required to deposit the cost of bidding document (as specified below) in the Sandhikharka Municipality, Rajaswa (revenue) account either by direct deposit in the Sandhikharka Municipality account for the purchase the bids as specified below.

6. Sealed Bids must be submitted to the office of **Sandhikharka Municipality Arghakhanchi** on or before 12:00 hours (noon) on 4th July, 2016 (20th Ashar, 2073 BS). Documents received after this deadline shall not be accepted.
7. Bids shall be opened physically in the presence of Bidders' representatives who choose to attend at **13:00 hours** on 4th July, 2016 (20th Ashar, 2073 BS) at the office of **Sandhikharka Municipality Arghakhanchi**.
8. Pre-Bid meeting shall be held at the office of **Sandhikharka Municipality Arghakhanchi** at 14:00 hours on 30th June 2016 (16th Ashar 2073 BS).
9. If the last date of submission and opening and pre-bid meeting falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
10. Bidders are advised to visit and assess the actual site condition before submitting their bids.
11. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason whatsoever.
