1. *Sandhikharka Municipality* invites electronic bids from eligible bidders for the construction of *Upgrading of Roads in Sandhikharka Municipality Bazaar -1 and 2* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 7,10,00,000.00**
  - Minimum Work experience of similar size and nature: **One Project within 5 years with a value of at least 3,16,00,000.00**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Pre-bid meeting shall be held at *Sandhikharka Municipality, Sandhikharka* at **2:00 PM on 10<sup>th</sup> September, 2023**
6. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) before **12:00 PM** on 21<sup>st</sup> **September, 2023**. The bids will be opened in the presence of Bidders' representatives who choose to attend at 21<sup>st</sup> **September, 2023, 12:10 PM** at the office of **Sandhikharka Municipality, Sandhikharka, Arghakhanchi**. Bids must be valid for a period of 90 **days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid./amounting to a minimum of Rs. **16,00,000.00** which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
