1. Sandhikharka Municipality invites electronic bids from eligible bidders for the **procurement of Supply and installation Surveillance system for Highway** under National competitive bidding- Single Stage Single Envelope procedures.

4. Pre-bid meeting shall be held at Sandhikharka Municipality, Sandhikharka Arghakhanchi at 1:00 pm on 6th Feb. 2023
5. Electronic bids must be submitted to the through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:PM** on **17th February, 2023**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:10 Pm **17th February, 2023**, at the office of Sandhikharka Municipality, Sandhikharka Arghakhanchi. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **57,000.00**, which shall be valid for 30 days beyond the validity period of the bid (16th June, 2023)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bidding document without assigning any reason, whatsoever.
