- The Government of Nepal [GoN] has allocated funds from GoN towards the Agriculture Market Infrastructure Construction of Clod Store and Hat Bazar Stall Construction and intends to apply part of the funds to cover eligible payments under the Contract for NCB/SMS/B/50/2077/078. Bidding is open to all eligible as per Section V of bidding document..
- 2. Sandhikharka Municipality invites electronic bids from eligible bidders for the construction of Agriculture Market Infrastructure Construction of Clod Store and Hat Bazar Stall Construction under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years: NRs.5,91,00000.00
- Minimum Work experience of similar size and nature: <u>1 building within 5 years with a value of at least 6,30,00,000.00</u>
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 23rd April. 2021 12:30 PM at the office of Sandhikharka Municipality, Sandhikharka, Arghakhachi.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
